**Subject: Constitution of Steering Committee for considering the proposals of NGOs.**

The Governor of Punjab is pleased to reconstitute a steering committee for considering the proposals of NGOs and also for declaring the mother units in respect of development works in the State of Punjab, as per policy for support to Voluntary Organisations/Non-Government Organisations in Punjab.

The Composition of the Steering Committee is as follows:-

1.	Secretary to Govt. Punjab Punjab State Planning Board	Chairman
2.	Joint Secretary to Govt. Punjab Punjab State Planning Board.	Member
3.	Representative of the Department of Health and Family Welfare, Punjab	Member
4.	Representative of the Department of Rural Development including Rural Sanitation, Punjab	Member
5.	Representative of the Department of Welfare of SCs and BCs, Punjab	Member
6.	Representative of the Department of Social Security and Women and Child Development, Punjab	Member
7.	Representative of the Department of Education, Punjab	Member
8.	Representative of CAPART	Member
9.	Head of Social Services Division Punjab State Planning Board	Member Secretary

The terms of reference of the committee will be as under:-

1. To consider the proposals of NGOs for grant-in-aid for specific development activities not covered by the department of Health, Education, Rural Development, Social Justice and Welfare.
2. To monitor and review the performance of NGOs to whom the grant has been released.
3. To decide any other issue which has been brought to the notice of the committee by any NGO.
4. To issue Guidelines/Instructions for expenditure to be incurred by the NGOs out of the Grant-in-aid given by Punjab Govt.

5. Any other function as assigned by the Chairman of the Committee.
6. The committee shall meet at least once in a quarter at a place to be decided by the Chairman.
7. The tenure of the committee shall be three years.
