Functions:

The State Planning Board will:

- i) make an assessment of the material and human resources of the state including Technical personnel and investigate the possibilities of augmenting such of these resources as are found to be deficient in relations to the State's requirements;
- ii) formulate a long term perspective plan for most effective and balanced utilisation of the State's resources;
- iii) evolve short-term strategy (Five Year Plan) for the planned, development, after examination of different approaches so as to evolve a maximum growth rate, keeping in view the need for social justice.
- iv) identify factors which tend to retard economic and social development of the State and determine conditions to be established for successful execution of the plans;
- v) review the progress of implementation of the plan programme and recommend such adjustments in policies and measures as the review may indicate;
- vi) assist district authorities in formulating their development plans within the spheres in which such Planning is considered useful and feasible and to coordinate these plans with the State Plans;
- vii) makes such interim or ancillary recommendations as appear to be appropriate either for facilitating the discharge of the duties assigned to it, or on a consideration of the prevailing economic conditions, current policies, measures and development programs, or on examination of such specific problems as may be referred to it for advice by the Govt.

Terms and Conditions of Appointment

The term of the Board constituted vide this Notification will initially be for a period of one year from the date of issue of the notification and which can be extended further with the consent of the Chairman.

The headquarter of the Board will be at Chandigarh. The Board or any of the Committee and Working Group constituted thereunder may, however, meet at any other place as and when considered necessary.
