Functions:

{i} make and assessment of the material and human resources of the State including Technical personnel and investigate the possibilities of augmenting such of these resources as are found to be deficient in relation to the State's requirements:

{ii} formulate a long-term prospective plan for the most effective and balanced utilization of the State's resources;

{iii} evolve short-term strategy {Five Year Plan} for planned development.; examination of different approaches so as to evolve a maximum growth rate, keeping in view the need for social justice;

{iv} identify factors which tend to retard economic and social development of the State and determine conditions to be established for successful execution of the plans;

 $\{v\}$ review the progress of implementation of the plan programme and recommend such adjustments in policies and measures as the review may indicate;

 $\{vi\}$ assist district authorities in formulating their development plans within the spheres in which such Planning is considered useful and feasible and to coordinate these plans with the State Plans;

{vii} makes such interim or ancillary recommendations as appear to be appropriate either for facilitating the discharge of the duties assigned to it, or on a consideration of the prevailing economic conditions, current policies ,measures and development programmes, or on examination of such specific problems as may be referred to it for advice by the Government.
