2. The terms of reference of the committee will be as under:-

1. To consider the proposals of NGO's for grant-in-aid for specific development activities not covered by the Department of Health, Education, Rural Development, Social Security and Women and Child Development, Welfare of SCs /BCs, Animal Husbandry, Dairy Development & Fisheries and Cultural Affairs.

2. To monitor and review the performance of NGO's to whom the grant has been released.
3. To decide any other issue which has been brought to the notice of the committee by any NGO.
4. To issue Guidelines/Instructions for expenditure to be incurred by the NGO's out of the Grant-in-aid given by Punjab Govt.
5. Any other function as assigned by the Chairman of the Committee.
6. The Committee shall meet at least once in a quarter at a place to be decided by the Chairman.
7. The tenure of the committee shall be three years.
